RECOGNITION ORDER

1. Whereas in terms of Section 14 of the NCTE Act, 1993 **MPSRES BHOPAL, PLOT NO. - 88/2/2/KH, AMARPURA ROAD, NEAR RATIBAD, VILLAGE - AMLA, P.O - JHAGARIYA KHURD, TEHSIL - HUJUR, DIST - BHOPAL - 462044, MADHYA PRADESH (APP1988)** had submitted an application to the Western Regional Committee of the NCTE on 18.12.2012 for grant of recognition to **MAHARANA PRATAP COLLEGE, PLOT NO. - 88/2/2/KH, 88/2/2/D, 88/2/2/CH, AMARPURA, VILLAGE - AMLA, P.O - JHAGARIYA KHURD, TEHSIL - HUJUR, DIST - BHOPAL - 462044, MADHYA PRADESH** for starting the **B.Ed. (CO-ED)** course with an annual intake of **100** students.
2. **AND WHEREAS**, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, laboratory and that it fulfills such other conditions required for proper functioning of the institution for **B.Ed.** course as determined by regulations.
3. NOW THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to **MAHARANA PRATAP COLLEGE, PLOT NO. - 88/2/2/KH, 88/2/2/D, 88/2/2/CH, AMARPURA, VILLAGE - AMLA, P.O - JHAGARIYA KHURD, TEHSIL - HUJUR, DIST - BHOPAL - 462044, MADHYA PRADESH (WRCAPP1988)** for starting **B.Ed. (CO-ED)** Course of Secondary level of **1 Years** with an annual intake of **100** from the **academic session 2014-2015**.
4. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.
5. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.
6. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.
7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.

If, at any time, either on *sue-moto* inspection or on any representation received from any person, the WRC, NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or the rules, regulations, orders made or issued there under or any condition subject to which the recognition/permission was granted, the recognition/permission may be withdrawn under the provisions of Section 17 (1) of the NCTE Act.
